**TENDER NOTICE FOR DISPOSAL OF CONDEMNED VEHICLE**

1. Tamil Nadu Trade Promotion organisation (TNTPO) invites sealed quotations for the disposal of the following vehicle on “as is where is” basis :-

2. Interested Parties may submit their highest quotations in the enclosed pro-forma (Annexure-I). The quotation in sealed cover, superscribed as “QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE” should be addressed to the “Managing Director, TNTPO, Chennai Trade Centre (CTC), Nandambakkam, Chennai-600089” and may be dropped in the tender box kept in Admin block of CTC, latest by 10.01.2019 at 3,00 PM. The quotations will be opened on the same day at 4.00 PM Chennai Trade Centre, Nandambakkam, Chennai – 600 089. The bidders, who wish to be present at the time of opening, may do so.

3. The vehicles will be available for inspection between 11:00 AM to 5:00 PM on all working days in Chennai Trade Centre till 2:00 PM on 10.01.2019.

4. The sale will be governed by the following terms and conditions:-

(i) The bidder is required to pay an earnest money of Rs.15,000/- in the form of Demand Draft in favour of “Tamil Nadu Trade Promotion Organisation” payable at Chennai along with the quotation. The quotation received without earnest money will not be considered as valid and shall not be accepted.

(ii) The bids received after the stipulated date and time i.e. 3:00 PM on 10.01.2019 will not be accepted. The bids received through e-mail/FAX/ telegram will not be considered. However, bids through speed-post/registered post will be considered only if received before the stipulated date and time.

(iii) The bids with overwriting/cuttings in the quoted rates will not be considered.

(iv) The bidders will not be allowed to withdraw their bids, failing which their earnest money will be forfeited.

(v) The successful bidder will be required to deposit the entire bid money by means of Demand Draft in favour of “Tamilnadu Trade Promotion Organisation” within two working days of the acceptance of the bid. The earnest money of the successful bidder will be released only after he deposits the sale proceeds. The earnest money will be forfeited in case he backs out for whatever reason.

(vi) The earnest money of unsuccessful bidders will be returned without interest.

(vii) The delivery of the sold vehicle will be arranged only after production/submission of proof of the residential status {Ration Card/Voter Identity Card/Aadhar Card in case of individual and Registration Certificate in case of firms etc.}

(viii) The sold vehicle has to be removed by the successful bidder from Chennai Trade Centre within 48 hours of depositing the sale proceeds and at their own expenses.

(ix) The vehicle will be disposed off on “**as is where is**” basis and no guarantee for its worthiness or quality will be given by this Organisation.

(x) It is the responsibility of the successful bidder to get the relevant papers of the vehicle transferred in his own name and to pay tax, etc. The TNTPO will not be responsible for any lapse on his part in this regard.

(xi) The undersigned reserves the right to accept or reject any/all of the quotations or cancel the tender at any time without assigning any reason.

(xii) The successful bidder who takes possession of the vehicle would be responsible for the bonafide use of the vehicle.
